The topics approached were:

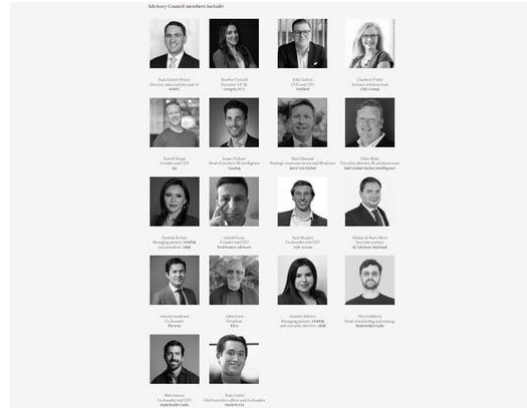
- VEKTOR Criteria for 2023 and details about the evaluation period
