

Participation at the Consultation on the Draft Law

Amendment for Law no. 24/2017 at ASF

ARIR participated in a consultation regarding the amendment of Law 24/2017 organized by the Financial Supervisory Authority, at the invitation of ASF's Vice President, Mrs. Gabriela Horga. ARIR members welcomed the changes included compared to the draft submitted for Public Debate by the Ministry of Finance in February, especially regarding the process of capital increases, maintaining quarterly reporting, and clarifications brought to the reporting process of issuers. The draft law amendment is set to go through the legislative process in Parliament, and ARIR will continue monitor this process.

[Antibiotice](#), ARIR's associate member, has commissioned a 2.5 MW photovoltaic plant, financed through the National Recovery and Resilience Plan (PNRR), an investment that is part of the company's sustainable development strategy.

The photovoltaic plant is expected to generate an average of 3,500 MWh/year and will cover 26.4% of the industrial platform's energy needs, based on the consumption recorded in 2021.
